**PLEASE READ THIS SOFTWARE LICENSE AGREEMENT ("LICENSE") CAREFULLY BEFORE USING INVOY FOR THE FIRST TIME. BY OPENING THE "INVOY" SOFTWARE APPLICATION YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE AND SERVICE TERMS AND CONDITIONS INCLUDED BELOW. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE AND CONDITIONS, DO NOT OPEN THE "INVOY" SOFTWARE APPLICATION.**

**1. General.** The software and documentation accompanying this License on any media and in any form (collectively the "Empty Factory / Wigwag Software") are licensed, not sold, to you by Empty Factory / Wigwag for use only under the terms of this License, and Empty Factory / Wigwag reserves all rights not expressly granted to you. The rights granted herein are limited to Empty Factory / Wigwag's intellectual property rights in the Empty Factory / Wigwag Software and do not include any other patents or intellectual property rights. Empty Factory / Wigwag retains ownership of the Empty Factory / Wigwag Software.
