

**LICENSE AGREEMENT  
FOR LOGITECH® IO™ REDISTRIBUTABLE SOFTWARE**

IMPORTANT – READ CAREFULLY BEFORE DOWNLOADING, COPYING, INSTALLING, OR OTHERWISE USING THE SOFTWARE AND DOCUMENTATION AVAILABLE ON THE LOGITECH IO BUSINESS SOLUTIONS SITE.

This License Agreement (“Agreement”) is a legal agreement between you, either an individual or an entity, (“you”) and “Logitech” as defined below. If you are located in North America, Latin America, Australia or New Zealand, “Logitech” means **Logitech Inc.**, with its principal place of business at 6505 Kaiser Drive, Fremont, California 94555 U.S.A. If you are located in Europe, the Middle East or Africa, “Logitech” means **Logitech Europe, S.A.**, with its principal place of business at Z.I. Moulin du Choc D, CH-1122 Romanel-sur-Morges, Switzerland. If you are located in Asia, “Logitech” means **Logitech Far East Ltd.**, with its principal place of business at #2 Creation Road IV, Science-Based Industrial Park, Hsinchu, Taiwan R.O.C.

BY DOWNLOADING, COPYING, INSTALLING OR OTHERWISE USING THE SOFTWARE OR DOCUMENTATION AVAILABLE ON THE LOGITECH IO BUSINESS SOLUTIONS SITE, YOU ARE AGREEING TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS AND CONDITIONS OF THIS AGREEMENT, OR IF YOU ARE ENTERING INTO THIS AGREEMENT ON BEHALF OF AN ENTITY AND YOU ARE NOT AUTHORIZED TO BIND SUCH ENTITY, DO NOT DOWNLOAD, COPY, INSTALL OR OTHERWISE USE THE SOFTWARE OR DOCUMENTATION.

1. **Definitions.** In this Agreement, the terms that are capitalized shall have the meaning set forth below or elsewhere in this Agreement, as the case may be.

1.1 **“Affiliate”** means any entity which directly or indirectly controls, is controlled by or is under common control with Logitech. For purposes of this definition, “control” shall mean beneficial ownership of more than fifty percent (50%) of the shares of the subject entity entitled to vote in the election of directors (or, in the case of an entity that is not a corporation, for the election of the corresponding managing authority).

1.2 **“End User”** means any party that obtains a copy of the Software solely for such party’s own personal or business use and not for resale or redistribution.

1.3 **“Enterprise Market”** means the market for selling products business to business, such as, but not limited to, a corporate entity or organization.

1.4 **“Documentation”** means any and all of the End User documentation and or other written materials, whether in paper or electronic format, made available to you by Logitech, and any Updates thereto.

1.5 **“Logitech Product”** means any Logitech personal digital pen product for the Enterprise Market.

1.6 **“Logitech Trademarks”** means the Logitech and Logitech io names and logos.

1.7 **“Retail Market”** means the market for selling products directly to consumer end users through publicly available channels, such as, but not limited to, a web site, product catalogue, or retail store outlet.

1.8 **“Software”** means the Logitech io software for digital pens identified as “Pen Software Version 2.0.303.1 (Enterprise),” and any Updates thereto.

1.9 **“Update”** means any new version, improvement, correction, modification, alteration, revision, extension, upgrade, and/or enhancement to the Software supplied by Logitech.

1.10 **“Your Software”** means any software application or suite of software applications that is developed directly or indirectly by you and sold or licensed under your trade name or trademarks, and which is compatible for use with the Logitech Product.

## **2. Limited License & Restrictions.**

2.1 Logitech grants to you a non-exclusive, nontransferable, revocable right and license to reproduce the Software, in object code (machine readable) form only, and to market, distribute and transfer the Software within the Enterprise Market solely in combination with Logitech Products (collectively the “Bundle”) either (i) as a standalone Bundle; or (ii) as a Bundle in combination with Your Software.

2.2 Pursuant to a written license agreement substantially in the form of this Agreement, you may sublicense the right to reproduce the Software to a third party CD-ROM duplicator (“Your Duplicator”), provided that Your Duplicator is permitted to reproduce the Software solely for use by you as permitted hereunder. You assume full responsibility and liability for any acts or omissions by Your Duplicator that are contrary to the terms and conditions of this Agreement.

2.3 Further, you may sublicense copies of the Software to End Users in the Enterprise Market for use in connection with the applicable Logitech Products, provided that such sublicensing is subject to an end user license agreement substantially in the form of the form “End User License Agreement” set forth in **Exhibit 1** to this Agreement, attached and incorporated herein by this reference. In such End User License Agreement, you shall insert your full legal name in the place where it states: “Insert Distributor’s full legal name above.”

2.4 You may copy, in whole or in part, any Documentation supplied to you by Logitech, for distribution to End Users, provided that you include the copyright and proprietary notices, if any, included in such Documentation. Logitech also grants you a non-exclusive, nontransferable, revocable right and license to translate the Documentation into other languages for purposes of providing localized documentation to End Users, provided that any such translated versions retain the same meaning and context as the original English-language Documentation supplied to you by Logitech.

2.5 You understand and agree that the Software and any Logitech Products that you bundle with the Software are not intended for resell, distribution, or other transfer without appropriate end user documentation. You represent and warrant that you will only transfer the Software and Logitech Products with appropriate end user documentation including, without limitation, any required regulatory agency notices such as FCC, CE and other compliance statements; end user warranties; ergonomic information on use of the Logitech Product; information concerning proper handling, use and disposal of batteries; laser and eye safety warnings; privacy policy statements; and any other information required by local laws. Logitech agrees to provide you with reasonable assistance in meeting such requirements; however,

regardless of any information that Logitech may provide to you, including without limitation any Documentation, you shall be solely responsible and liable for complying with this Section 2.5 and any applicable laws and regulations. You agree to indemnify, defend and hold harmless Logitech for any breach of this Section 2.5.

2.6 Other than as expressly set forth above, you agree not to distribute or otherwise transfer the Software or Documentation. In particular, you understand and agree that you will not distribute or otherwise transfer the Software or any Logitech Products in the Retail Market. No right is granted to any source code of the Software and neither you nor Your Duplicator shall modify in any way, create derivative works of, reverse engineer and/or decompile or disassemble the Software.

2.7 Nothing in this Agreement is intended to limit Logitech's rights to directly or indirectly sell, manufacture, or license products identical or similar to the Software.

### **3. Limited Warranty.**

3.1 Limited Warranty on Software. Logitech warrants that the master copy of the Software provided by Logitech to you shall perform substantially in accordance with the Software's then-current release notes for a period of ninety (90) days from the date you first downloaded the Software, which shall be deemed to be the date on which you first submitted your online registration to Logitech (the "Warranty Period"). You acknowledge that the Software is complicated, and Logitech does not warrant that the operation of the Software shall be uninterrupted or error free, or that all errors can be corrected. You shall promptly notify Logitech in writing if any Software does not perform substantially in accordance with the then-current release notes and include a written explanation of how the Software fails to substantially comply, along with other supporting information and materials that are reasonably requested by Logitech to verify, diagnose, and correct such noncompliance. Upon receipt of such written explanation and supporting information, Logitech shall use commercially reasonable efforts to modify the Software so that it substantially performs in accordance with the release notes in effect at the time you first submitted your online registration to Logitech.

3.2 No Warranty on Documentation. All Documentation supplied by Logitech is provided "AS IS" without warranty of any kind.

3.3 NO OTHER WARRANTIES. THE LIMITED WARRANTY GRANTED IN THIS SECTION 3 IS IN LIEU OF ALL OTHER WARRANTIES, EXPRESS OR IMPLIED, AND LOGITECH AND ITS AFFILIATES EXPRESSLY DISCLAIM ALL OTHER WARRANTIES INCLUDING, BUT NOT LIMITED TO, THE IMPLIED WARRANTIES OF MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE, NONINFRINGEMENT OF THIRD-PARTY RIGHTS AND ANY WARRANTIES OF NON-INTERFERENCE OR ACCURACY OF INFORMATIONAL CONTENT WITH RESPECT TO THE SOFTWARE AND DOCUMENTATION. THE REMEDIES SET FORTH ABOVE DESCRIBE YOUR SOLE AND EXCLUSIVE REMEDY AND LOGITECH'S ENTIRE LIABILITY WITH RESPECT TO A BREACH OF WARRANTY REGARDING THE SOFTWARE, DOCUMENTATION OR ANY OTHER MATERIALS SUPPLIED HEREUNDER.

3.4 The limited warranty granted under this Section 3 is personal and extends only to you. You shall be responsible for warranting the performance of the Software and providing support to your customers. You acknowledges that the terms of this Agreement are structured with the understanding that you provide such warranty and technical support to your customers.

4. **Trademarks.** Logitech grants to you a non-exclusive, limited right and license to use the Logitech Trademarks on marketing, advertising and promotional materials during the term of this Agreement in connection with marketing of the Software as permitted under this Agreement and subject to Logitech's trademark usage guidelines. You agree not to use the Logitech Trademarks in any manner that might suggest the qualification, certification or any form of endorsement of Your Software by Logitech. You agree that the Logitech Trademarks are and will remain the sole property of Logitech and all use and goodwill associated therewith will inure solely to the benefit of Logitech. You further agree not to register nor attempt to register any Logitech Trademarks or confusingly similar trademarks and that you will not do anything inconsistent with nor contest Logitech's ownership of the Logitech Trademarks.

5. **Proprietary Rights Notices.** You agree that each copy of the Software distributed by you shall contain all of the proprietary notices in the same form in which they appear on or in the Software, as supplied to you by Logitech. You also agree to include a copyright notice in the following format on all tangible copies of the Software in such a manner that at system boot time or sign-on, or in an "about box", if any, the copyright notice appears on the screen:

6. **Ownership.** Logitech and its Affiliates shall retain all ownership of the Software. Other than as expressly set forth herein, you are not granted any license, express or implied, to use any of the technology or intellectual property rights owned by Logitech or its Affiliates.

7. **Restricted Rights.** In the case of sale to, or use of the Software by the U.S. Government, any use, duplication, or disclosure by the U.S. Government is subject to restrictions set forth in this Agreement and as provided in DFARS 227.7202-1(a) and 227.7202-3(a) (1995), DFARS 252.227-7013(c)(1)(ii) (OCT 1988) FAR 12.212(a) (1995), FAR 52.227-19, or FAR 52.227-14 (ALT III), as applicable. Logitech Inc. 6505 Kaiser Drive, Fremont, CA 94555.

8. **Term and Termination.** The term of this Agreement shall begin on the date you first submitted your online registration to Logitech ("Effective Date"). Subject to the terms herein, this Agreement shall expire on the first anniversary of its Effective Date and shall automatically renew for up to three (3) additional one (1) year periods, unless earlier terminated as provided herein. Upon any violation of any of the provisions of this Agreement, the rights and licenses granted to you under this Agreement shall automatically terminate and the Software and Documentation must be returned to Logitech, or all copies destroyed. You may also terminate this Agreement at any time by destroying all copies of the Software and Documentation in your possession or control. Further, upon thirty (30) days written notice, either you or Logitech may terminate this Agreement with or without cause. Termination of this Agreement shall not affect the rights of End Users who have received the Software subject to an effective end user license agreement.

9. **LIMITATION OF LIABILITY.**

IN NO EVENT SHALL LOGITECH OR ITS AFFILIATES BE LIABLE TO YOU FOR ANY SPECIAL, INDIRECT, INCIDENTAL, OR CONSEQUENTIAL DAMAGES (INCLUDING WITHOUT LIMITATION COSTS OF PROCUREMENT OF SUBSTITUTE PRODUCTS, LOST PROFITS, OR LOST DATA) ARISING IN ANY WAY OUT OF THIS AGREEMENT ON ANY THEORY OF LIABILITY INCLUDING WITHOUT LIMITATION CLAIMS BASED ON BREACH OF CONTRACT, TORT, NEGLIGENCE OR OTHER FORM OF ACTION, REGARDLESS OF WHETHER LOGITECH OR ITS AFFILIATES HAS BEEN ADVISED OF THE POSSIBILITY OF

SUCH LOSS OR DAMAGE AND NOTWITHSTANDING ANY FAILURE OF ESSENTIAL PURPOSE OF ANY LIMITED REMEDY. FOR THE PURPOSE OF THIS SECTION 9, LOGITECH CONTRACTS ON BEHALF OF ITSELF AND ITS AFFILIATES AND EMPLOYEES.

## **10. General Provisions.**

**10.1 Notices.** Any notice required to be given hereunder shall be in writing and shall be given by delivery by professional courier, or sent by first class mail, return receipt requested, postage prepaid.

Notices to you shall be sent to the address provided by you during the online registration process. Either you or Logitech may notify the other of a new address and contact for notices by sending notification pursuant to this Section 10.1. Any notice sent hereunder shall be deemed to have been given two (2) days after deposit in the mail or one (1) day after delivery to the overnight courier.

**10.2 Entire Agreement.** This Agreement and the exhibits hereto constitutes the entire agreement between you and Logitech regarding its subject matter. This Agreement supersedes and its terms govern all prior proposals, agreements, or other communications (written or oral) between you and Logitech regarding this subject matter. Except as set forth in Section 10.3, this Agreement shall not be modified except by a writing that refers explicitly to this Agreement and that is signed by you and an authorized representative of Logitech.

**10.3 Modification of Agreement.** Logitech may modify the terms and conditions contained in this Agreement by posting a change notice or a new agreement on its web site or by sending you written notice thereof. IF ANY MODIFICATION IS UNACCEPTABLE TO YOU, YOUR ONLY RECOURSE IS TO TERMINATE THIS AGREEMENT. YOUR CONTINUED USE OF THE SOFTWARE OR DOCUMENTATION FOLLOWING LOGITECH'S POSTING OF A CHANGE NOTICE OR NEW AGREEMENT ON ITS WEB SITE OR BY SENDING YOU WRITTEN NOTICE WILL CONSTITUTE YOUR BINDING ACCEPTANCE OF THE CHANGE.

**10.4 Relationship of the Parties.** The relationship between you and Logitech shall be that of seller and buyer and independent contractors. You shall not have the right to enter into any contracts or binding commitments in the name of or on behalf of Logitech or any of its Affiliates in any respect whatsoever.

**10.5 Export.** You agree that you will not export the Software, Documentation or Logitech Products, except in compliance with all applicable export regulations, and that your agreements with any third parties, including Your Duplicator and End Users, shall require their compliance with this requirement.

**10.6 Governing Law.** If you are located in North America, Latin America, Australia or New Zealand, this Agreement shall be governed by the laws of the United States and the State of California without reference to conflicts of law principles, and you and Logitech hereby

consent to the exclusive jurisdiction of the federal or state courts in the districts that include Fremont, California. If you are located in Europe, the Middle East or Africa, this Agreement shall be governed by the laws of Switzerland, without reference to conflicts of law principles, and you and Logitech hereby consent to the exclusive jurisdiction of the courts in Geneva, Switzerland. If you are located in Asia, this Agreement shall be governed by the laws of Taiwan, R.O.C., without reference to conflicts of law principles, and you and Logitech hereby consent to the exclusive jurisdiction of the courts in Taipei, Taiwan, R.O.C. You and Logitech agree that the United Nations Convention on Contracts for the International Sale of Goods is specifically excluded from application to this Agreement.

For backup purposes only, you may make one copy of the Software, provided that you include all copyright and other notices included on the Software as supplied by \_\_\_\_\_ and its licensors.

**12. General Terms and Conditions.** This Agreement will be governed by and construed in accordance with the laws of the United States and the State of California, without regard

to or application of its choice of law rules or principles. If for any reason a court of competent jurisdiction finds any provision of this Agreement, or portion thereof, to be unenforceable, that provision of the Agreement shall be enforced to the maximum extent permissible so as to affect the intent of the parties, and the remainder of this Agreement shall continue in full force and effect. This Agreement constitutes the entire agreement between the parties with respect to the use of the Software and supersedes all prior or contemporaneous understandings, communications or agreements, written or oral, regarding such subject matter.
